Our primary focus is that our football coaching sessions and match days are delivered with a professional academy flavour.


We will aim to provide development opportunities for players to grow, become confident, creative, brave, expressive, and technically/tactically game aware with and without the ball.

St Andrews Football Club: Player Membership

For the 2024/25 season the club will have a signing on fee of £25 per player (payable with the first monthly subscription fee) alongside a monthly subscription fee, payable by standing order. As such, there will be no match day subs or additional training fees throughout the season.

St Andrews FC will offer a 15% sibling discount on the monthly fee, however the signing on fee remains the same as the fee in the table below.

The following is included within both fees:

Fees also cover hidden costs including venue hire, referee costs, pitch marking and much more for the club to be sustainable.

Monthly fees will be by Standing Order only (unless pre-agreed with the Treasurer) and will run from **August 1st until June 1st** A total of 11 months with a break in payments in **July**.

If a member falls behind on payments, then their membership will cease (unless pre-agreed with the committee) and they will be unable to train or take part in matches.

St Andrews Football Club: Child Welfare

Child welfare is taken very seriously by the club.

Although very rare, an incident may occur during matches (or training) involving parents, coaches, officials, and the players which could be seen as endangering Child Welfare. This may be either verbal or physical. In this unfortunate event coaches are asked to contact the club via the secretary as soon as possible before taking any other course of action. Once the club has been notified the Committee will take the matter in hand and liaise with the coach on next steps and procedures.

St Andrews Football Club: GDPR

St Andrews Football Club FC take individual data protection very seriously. By completing the Player Registration form you agree that the club have the right to store your personal data and that of the player. This personal data will only be stored for as long as the player remains a member of the club, once membership ceases all documents will be destroyed.

St Andrews Football Club: Sponsorship

The club are always looking for sponsors for kits and training tops, if you can sponsor or know someone who can sponsor kits or training tops for our club or teams then please make your coach or the committee aware.



St Andrews Football Club: Club Rules

Players cannot be signed to another Club in the same League, players **MUST** receive permission from the committee to play for another club in a different league and should prioritise St Andrews FC fixtures. Managers/Coaches are only responsible for children whilst they remain on the designated site. All children must be brought and collected by an appropriate adult, unless specific written consent from the parent/guardian has been received by the Club.

Please advise in advance (before noon of the day of training) if you cannot make training or will be late. **For matches always arrive at the ground no later than 30 minutes before kick-off unless pre agreed.**

Although every care will be taken, site exits are not secured, and Managers/Coaches cannot be responsible for children who leave the site without first notifying them.

Please accept that **no player has an automatic right to play the position he/she wants.**

All St Andrews FC participants including Parents/Guardians/Spectators will be required to adhere to the code of conduct guidelines and any participant behaving unacceptably will receive a formal warning. Any participant receiving more than two such warnings may be excluded from attending any further activities for a period decided by the Committee.

Unacceptable behaviour includes, but is not limited to, swearing, smoking, deliberately endangering others, and disrupting activity sessions, but also includes behaviour that the Club feels is inappropriate and/or affects the enjoyment of the Club by other children.

Parents, players, spectators, children, coaches, managers and any other official of St Andrews FC must adhere to the FA Respect campaign. Those not adhering could face disciplinary action.

Shin pads **MUST** be worn for all training sessions and matches. Each player must provide their own shin pads and football boots. **Any player failing to wear shin- pads will not be allowed to train or play in that match.**


Any player issued with team kit (including training kit), will be held responsible for any loss/damage caused and will be invoiced by the club. Should a player leave the Club, the kit (unless paid for by the player themselves) must be returned to the team manager as it remains the property of St Andrews FC.

Any child regularly not attending training or matches, for no apparent good reason, could lose their place within the Club. It is up to a Manager/Coach to decide what is reasonable. However, any decision to remove a child from their team will be first discussed with the child's parent(s) and second, be approved by the Committee.

In the event of any dispute between a parent, player, coach or manager, all parties should in the first instance seek to resolve the issue/concern privately via a face-to-face meeting. If an agreement cannot be reached, then the party with the grievance should refer the matter to the Committee. The Committee's decisions will be viewed as final.

SOCIAL MEDIA: Any player, parent, guardian, or carer seen to be making defamatory comments about the club, coaches, other players, club officials, match officials, the league, opposition, or the FA will be asked to meet with the committee and could be asked to leave the club.

IMPORTANT: Any player incurring Wilshire FA punishments/fines may be asked to meet with the Committee to explain their behaviour and may receive a formal warning and **WILL** be required to pay the fine.



St Andrews Football Club:

Celebrating football through photographs and video

"There has been much talk about who is allowed to take pictures of children (under 18s) playing sport and in particular what parents/carers are permitted to do. The FA would like to assure parents, carers, coaches, spectators, players, and local media that we encourage the taking of appropriate images of children in football."

It is important to remember that the majority of images taken are appropriate and in good faith. St Andrews has taken the following measures to ensure the safety of children in football.

We will.

- Focus on the activity rather than the individual.
- Ensure all those featured are appropriately dressed (a minimum of vest or shirt and shorts)
- Aim to take pictures which represent the broad range of children participating safely in football.

We will not.

- Publish photographs with the full name(s) of individual(s) featured unless we have written consent to do so, and we have informed you how the image will be used.
- Use player profiles with pictures and detailed personal information on our website!
- Use an image for something other than which it was initially agreed.
- Allow images to be recorded in changing rooms, showers, or toilets - this includes the use of mobile phones that record images.

Filming as a coaching aid.

The FA advises that coaches using videoing as a legitimate coaching aid should make parents/carers and players aware that this will be part of the coaching programme. Care should be taken when storing the videos.

At times throughout the season FC Wiltshire will make use of filming to aid in coaching sessions. These images will not be used for any other purpose and will not be stored by any coach after the session and subsequent learning has been completed.

If you are concerned about the inappropriate use of images, please report this to Andy Mullen, St Andrews FC Welfare Officer (07850 450319)

Remember.

- It's not an offence to take appropriate photographs in a public place even if asked not to do so.
- No one has the right to decide who can and cannot take images on public land.
- If you have serious concerns about a possible child protection issue relating to the recording of images, then call the Police. This action should only be taken where you believe that someone may be acting unlawfully or putting a child at risk.

Young Players	Spectators and Parents/Carers
<p>We all have a responsibility to promote high standards of behaviour in the game.</p> <p>As a player, you have a big part to play. That's why The FA is asking every player to follow a Respect Code of Conduct.</p> <p>When playing football, I will:</p> <ul style="list-style-type: none"> Always play to the best of my ability Play fairly – I won't cheat, complain, or waste time. Respect my team-mates, the other team, the referee, or my coach/manager. Play by the rules, as directed by the referee. Shake hands with the other team and referee at the end of the game. Listen and respond to what my coach/team manager tells me. Talk to someone I trust or the club welfare officer if I'm unhappy about anything at my club. <p>I understand that if I do not follow the Code, any/all the following actions may be taken by my club, County FA, or the FA.</p> <p>I may:</p> <ul style="list-style-type: none"> Be required to apologise to my team-mates, the other team, referee, or team manager. Receive a formal warning from the coach or the club committee. Be dropped or substituted. Be required to pay any fines incurred by yellow and red cards. Be suspended from training. Be required to leave the club. <p>In addition:</p> <ul style="list-style-type: none"> My club, County FA or The FA may make my parent or carer aware of any infringements of the Code of Conduct The FA/County FA could impose a fine and suspension against my club. <p>Social Media</p> <p>Players should never put anything defamatory about other players, about coaches, the club, opposition, club officials, referees, the league, or the FA on any social media sites including but not limited to Facebook, Twitter, Snapchat, and Instagram. Any players seen to be doing this will be asked to meet with the committee and could result in the player being asked to leave the club.</p>	<p>We all have a responsibility to promote high standards of behaviour in the game.</p> <p>This club is supporting The FA's Respect programme to ensure football can be enjoyed in a safe, positive environment. Remember children's football is a time for them to develop their technical, physical, tactical, and social skills.</p> <p>Winning isn't everything.</p> <p>Play your part and always observe The FA's Respect Code of Conduct for players.</p> <p>I will:</p> <ul style="list-style-type: none"> Remember that children play for FUN. Applaud effort and good play as well as success. Always respect the match officials' decisions Remain outside the field of play and within the Designated Spectators' Area (where provided) Let the coach do their job and not confuse the players by telling them what to do. Encourage the players to respect the opposition, referee, and match officials. Avoid criticising a player for making a mistake – mistakes are part of learning. Never engage in, or tolerate, offensive, insulting, or abusive language or behaviour. Never put anything defamatory about coaches, other players, the club, opposition, club officials, referees, the league, or the FA on any social media site including but not limited to Facebook, Twitter, Snapchat, and Instagram. This will result in the person involved being brought in front of the club committee and possibly asked to leave the club along with any dependents. <p>I understand that if I do not follow the Code, any/all the following actions may be taken by my club, County FA, or the FA.</p> <p>I may:</p> <ul style="list-style-type: none"> Be issued with a verbal warning from a club or league official. Be required to meet with the club, league or GFA Welfare Officer Be required to meet with the club committee. Be obliged to undertake an FA education course. Be obliged to leave the match venue by the club. Be requested by the club not to attend future games. Be suspended or have my club membership removed. Be required to leave the club along with any dependents.
